### GUIDING PRINCIPLES OF THE FRISCO CHAMBER OF COMMERCE

1. The government shall do no harm to the Frisco area business community or economy.
2. The government should limit taxes and government regulation except when doing so would constrain business growth.
3. The government should focus on issues and priorities that foster a favorable business community and job growth in the region including streamlining processes.
4. The government should maintain local control by keeping as many decisions and regulations as possible at the governance level closest to the people.
5. The Frisco Chamber of Commerce will take a “long-term” perspective in all of our advocacy efforts...not trading our future for short-term gains.
6. The Frisco Chamber of Commerce will advocate for legislation that promotes or maintains a fair and competitive business environment.

## Business

### Business Regulation

- Promote legislation that reduces red tape and supports business growth.
- Promote legislation that encourages competition locally and globally.
- Promote legislation that limits tax requirements that stifle business growth at all levels.
- Support initiatives that increase trade opportunities for businesses.
- Oppose legislation that limits the ability of the business community to engage in electoral and policy-making arenas.
- Oppose any unfunded mandates that will fall on local business owners.

### Economic Development

- Support legislation that supports and encourages local job growth and a business-friendly climate.

- Support continued funding for economic development programs such as the Texas Enterprise Fund, Texas Tourism, and the Texas Film Commission.
- Support legislation that encourages capital investment in Texas by protecting the Texas Economic Development Act (Chapter 313).
- Oppose any attempt to reduce a municipality's ability to use any currently available economic development tools.

## Public Education

- Support legislation to continue the funding promises made in the 86<sup>th</sup> legislative session through HB3.
- Support legislation to allow school districts to count as present for the purposes of Average Daily Attendance (ADA) students participating in virtual learning programs including locally-developed and approved online courses.
- Support investments in technology to ensure greater connectivity and access for students across Texas.

## Higher Education & Workforce

- Promote education development to allow Collin College and the University of North Texas (UNT) to create appropriate studies programming to meet the growing job needs across the region.
- Support UNT's request for a tuition revenue bond specific to the UNT campus in Frisco.
- Support initiatives to further the plans laid out in the Texas Higher Education Coordinating Board's 60x30TX plan.

## Health Care

- Support policies supporting market-based healthcare solutions that increase access and choice of healthcare programs.
- Support eliminating state and federal mandated benefits that significantly increase costs to employers and employees.
- Promote legislation that supports IT initiatives (such as telemedicine) where possible to reduce costs and enhance care.

# Infrastructure

## Transportation

- Promote legislation and funding for new construction for improved mobility along with appropriate funding for maintaining and rehabilitating existing and aging infrastructure.
- Promote innovative solutions to provide for 21<sup>st</sup>-century transportation needs.
- Support continuing the policy of no diversions from the Highway Trust Fund.
- Continuing to fund Propositions 1 and 7 with no interruptions, reductions, or diversions.
- Oppose efforts that would increase the cost or slow delivery of materials needed for public or critical infrastructure.

## Water

- Promote legislation that supports funding for building, maintenance, and rehabilitation of new and aging infrastructure.

- Promote responsible policies and projects that increase the quantity and quality of water for the City of Frisco and the region to further economic growth.
- Protect the use of eminent domain authority for water providers, to ensure the ability to provide a reliable and cost-effective water supply for the North Texas region.

## Energy

- Support legislation and regulatory actions that promote necessary and well-planned energy infrastructure development.
- Support legislation ensuring that electrical transmission planning is coordinated with local residential and commercial growth.

## Telecommunications

- Support the development of plans and compiling resources needed for greater broadband connectivity to enhance access to public education, healthcare, employment, news, and information.

# Governance

## Local Control

- Support policies that allow the local government to improve the local business community.
- Oppose attempts to limit or prohibit municipalities from using public funds to communicate with legislators and state agencies, as well as pay membership dues to organizations that hire lobbyists.
- Support amendments to HB 2439 to allow cities the ability to regulate building materials and methods.
- Support amendments to HB 3267 to create a more equitable process for both municipalities and developers.
- Oppose unfunded mandates placed on local municipalities.
- Oppose legislation that would impose revenue caps inhibiting growth and economic stability for political subdivisions.

## Redistricting

- Oppose any attempt to create a legislative district that does not wholly contain the city limits of Frisco notwithstanding the county-line rule.

## COVID-19

- Allow and promote decision-making at the city and county levels rather than the state and federal levels.
- Support legislation and executive orders that treat all businesses equally while dealing with the COVID-19 global health crisis.
- Support legislation that temporarily reduces or suspends the high stakes standardized testing requirements or adjusts the accountability standards to reflect the impacts schools have felt due to COVID-19.
